

# **The Procurement Project of Communication System for Metro Line 1 in Luoyang City**

## **Invitation for bidding**

Date: July 12, 2019

Guoxin Tendering Group Co., Ltd. (hereinafter referred to as "tendering agency") is entrusted by Luoyang Metro Group Co., Ltd. (hereinafter referred to as "tenderer") to conduct an international public bidding for BRICS member countries on Goods and Services required for The Procurement Project of Communication System for Metro Line 1 in Luoyang City. The mode of post-qualification examination is adopted for qualification examination of the bid. The project is divided into three packages. Now, intended and qualified bidders are invited to participate in the bidding.

The construction funds for this project is from the New Development Bank loan and the Chinese government allocations. The tenderer has acquired purchase funds and will ensure the smooth implementation of various contracts under this project.

### **1. Project Overview**

Project Overview: The project of Metro Line 1 in Luoyang City covers the east-west main passenger flow corridor in Luobei area with a total length of 22.768 km and is laid by underground line. There is a transfer station with Line 2, Line 3 and Line 4 in the planning network. The west end of the line is equipped with Hongshan Vehicle Base, which is connected with Hongshan Station; the east side is equipped with a Chandong parking lot which is connected with Yangwan Station. A control center is established which is shared by the the four lines of line network planning. The cable in line 1 section will be laid to the control center along the line 2 section in the future. This tender covers the supply and service of special communication system, police communication system and weak power supply (UPS, EPS) for the project of Metro Line 1 in Luoyang City.

### **2. The name, quantity, main specifications, time and place of delivery of the tendering goods**

#### **2.1 Name of goods:**

Package 01: Special communication system, including but not limited to dedicated transmission, official telephone, dedicated telephone, dedicated wireless, video monitoring,

clock, broadcast, passenger information, centralized alarm, digital centralized recording system, office automation system . See Chapter 8 of Book 2 "List of Goods Requirements and Technical Specifications" for details;

Package 02: Police communication system, including but not limited to police transmission system, police video monitoring subsystem, police fire protection wireless communication subsystem, police computer network subsystem, police wire telephone subsystem, police power supply and grounding subsystem. See Chapter 8 of Book 2 "List of Goods Requirements and Technical Specifications" for details;

Package 03: weak power supply (UPS, EPS), including but not limited to power supply and grounding subsystem, emergency power supply cabinet (EPS). See Chapter 8 of Book 2 "List of Goods Requirements and Technical Specifications" for details.

2. 2 Quantity: one batch;
2. 3 Main specifications: See Chapter 8 of volume 2, “Schedule of Requirements and Technical Specifications”.
2. 4 Delivery time: conform to the operation requirements. For more details, please refer to Chapter 8 of volume 2, “Schedule of Requirements and Technical Specifications”.
2. 5 Place of delivery: at the construction site or the designated place of the project of Metro Line 1 in Luoyang City. In accordance with site conditions, the tenderer has the right to do a moderate adjustment.

### **3. Requirements for Bidder's Qualification**

The bidder of package 01-03 of this project shall meet the following conditions of 3.1-3.10:

3. 1 The bidder is a legal person or other organization that responded to the bidding, purchased the bidding documents from the bidding agency and participated in the bidding competition. Any legal person or other organization that has not purchased the bidding documents from the bidding agency is not allowed to participate in the bidding;
3. 2 Any legal person or other organization from member countries of New Development Bank (hereinafter referred to as “qualified countries of origin”) may participate in the bidding;
3. 3 Any legal person or other organization that has conflict of interest with the tenderer and may have impact on fairness of the bidding is not allowed to participate in the bid;
3. 4 Legal persons or other organizations that are entrusted to participate in the preliminary consultation and bidding documents compiling shall not participate in the bidding, nor shall they provide consultation or bid documents compiling;

- 3.5 Different units have been controlled or managed by same person, they shall not participate in the bidding for the same project;
- 3.6 Only those suppliers who are legally and financially independent of the tenderer and the tendering agency can participate in the project bidding;
- 3.7 The tenderer shall complete the registration and verification of the information on the electronic trading platform for bidding and tendering of mechanical and electrical products (hereinafter referred to as "bidding network", url: <http://www.chinabidding.com>) prior to the deadline set out in the tendering documents, otherwise the tenderer shall be unable to enter the bidding procedure, and the consequences arising therefrom shall be borne by himself;
- 3.8 The goods provided by the bidder must be produced or assembled and commissioned in qualified countries/regions of origin;
- 3.9 The tenderer shall provide the audited financial statements and audit reports for the last three years (2015, 2016, 2017), and, if the law of the country where the bidder is located does not require, shall provide the financial statements acceptable to the tenderer, and shall reflect the financial situation of the bidder, and the bidder shall not lose money for three consecutive years;
- 3.10 The project does not accept the joint bidding.

At the same time, bidder of package 01 shall meet the following conditions:

- 3.11 The total turnover of bidders in the last three years (2015-2017) is not less than RMB 450 million Yuan or equivalent foreign currency (converted according to the selling price for cash transactions first issued by the Bank of China on the date of the tendering announcement);
- 3.12 Performance Requirements: From July 1, 2014 to the deadline for bidding, the bidder shall have the general contracting or integration performance of a special communication system for the project of urban Metro in operating in a qualified country/ region of origin (the performance shall include all the following equipment: dedicated transmission, official telephone, dedicated telephone, dedicated wireless, video monitoring, clock, broadcast, passenger information).

The bidder of package 02 shall also meet the following conditions:

- 3.11. The total turnover of the bidders in the last three years (2015-2017) is not less than RMB 150,000 Yuan or equivalent foreign currency (converted according to the selling price for cash transactions first issued by the Bank of China on the date of the tendering announcement);

3. 12. Performance Requirements: The bidder shall, from July 1, 2014 to the deadline for bidding, have the performance of general contracting or integration of a special communication system or police communication system for the project of urban Metro in operating in a qualified country/ region of origin.
- 1) The general contracting or integration performance of a dedicated communication system shall include all the following equipment: dedicated transmission, official telephone, dedicated telephone, dedicated wireless, video monitoring, clock, broadcasting, passenger information.
  - 2) The performance of police communication system shall include all the following equipment: police transmission system, police video monitoring subsystem, police fire protection wireless communication subsystem, police computer network subsystem, police wire telephone subsystem, police power supply subsystem and grounding subsystem.

The bidder of the package 03 shall also meet the following conditions:

3. 11. Bidders shall be manufacturers of UPS;
3. 12. The total turnover of bidders in the last three years (2015-2017) is not less than RMB 54 million Yuan or equivalent foreign currency (converted according to the selling price for cash transactions first issued by the Bank of China on the date of the tendering announcement);
3. 13. Performance Requirements: The bidder shall, from July 1, 2014 to the deadline for bidding, have the performance of a weak power supply (UPS) for the project of urban Metro in operating in a qualified country of origin/ region (which shall include a weak power source UPS at least).

Note:

- 1) Bidders may bid on multiple packages of the project at the same time, but only one package is allowed to win the bid.
- 2) Urban rail transit is limited to the urban Metro system.
- 3) The performance of the bidder as the subcontractor or not the leader of the consortium shall not be regarded as effective performance.
- 4) The performance should be effective only after scanning or photocopy of the main contents of the contract agreement or contract agreement (at least including the contract amount, equipment list, seal page and key content) and the official stamp-bearing user documents issued by the Metro company (including the subordinate sub companies) are provided,

otherwise it shall be deemed as invalid performance without valid certification materials.

**4. Selling price of tendering documents**

Tendering documents are priced at RMB 3,000 or US \$500 per package, and are not refundable after sale.

If needing mail-order, the postage should be paid (EMS fee 200 yuan for the domestic post, while pay another 20 US dollars for the foreign post). Please remit the price and mailing fee of the bidding documents according to the address listed following by Guoxin Tendering Group Co., Ltd. The purpose of the remittance and the number of the bidding documents purchased should be indicated on the remittance slip. Then the copy of the remittance slip, the name of the purchaser, the detailed communication address, postal code, telephone number, fax and contact name shall be faxed to Guoxin Tendering Group Co., Ltd After that, Guoxin Tendering Group Co., Ltd will send the bidding documents to you by express delivery as soon as possible upon receipt of the fax.

**Note: The bidder must remit the money from the account of your own when remittance, and indicate the name of the project participated. Otherwise, the bidder will bear the consequences of invalid bidding due to non conforming name of the bidder or unclear purpose of the payment.**
