

# **Invitation for Bidding of Bid 01 of Procuring Automatic Fare Collection (AFC) System for Luoyang Rail Transit Line 1 Project**

Guoxin Tendering Group Corporation Limited (hereinafter referred to as the "bidding agency") is entrusted by Luoyang Rail Transit Group Co., Ltd. (hereinafter referred to as the "Tenderee ") to carry out an international public bidding to members of BRICS for goods and services required by Bid 01 of Procuring Automatic Fare Collection (AFC) System For Luoyang Rail Transit Line 1 Project. The qualification examination method is post-qualification examination. Qualified bidders who are interested and conform to the regulations are invited to participate in the bidding.

The construction funds for this project is from the New Development Bank loan and the Chinese government allocations. The tenderer has acquired purchase funds and will ensure the smooth implementation of various contracts under this project.

## **1. Project Overview**

Luoyang urban rail transit line 1 project will be laid on the ground. There is a transfer station for Line 2, Line 3 and Line 4 in the planning network. The west end of the line is equipped with Hongshan vehicle base, which connects with Hongshan station. In the east, a parking lot will be set up to connect with Yangwan Station. Type B vehicles are selected, and the trains are grouped into six groups in the initial, short-term and long-term.

## **2. Name, quantity, main specifications, delivery time and place of delivery of the bidding goods**

- 2.1 Name of goods: system design, equipment procurement, commissioning and service etc of AFC and ACC, and see the Chapter VIII of Volume II: *the Goods Demand Schedule and Specification* for the details
- 2.2 Quantity: one batch;
- 2.3 Main specifications: See Chapter 8 of volume 2, "Schedule of Requirements and Technical Specifications".
- 2.4 Delivery time: conform to the operation requirements. For more details, please refer to Chapter 8 of volume 2, "Schedule of Requirements and Technical Specifications".
- 2.5 Place of delivery: Luoyang rail transit line 1 project construction site or the place designated by the Tenderee, and the bidder is responsible for unloading.

### **3. Requirements for Bidder's Qualification**

- 3.1 The bidder is a legal person or other organization that responded to the bidding, purchased the bidding documents from the bidding agency and participated in the bidding competition. Any legal person or other organization that has not purchased the bidding documents from the bidding agency is not allowed to participate in the bidding;
- 3.2 Any legal person or other organization from member countries of New Development Bank (hereinafter referred to as "qualified countries of origin") may participate in the bidding;
- 3.3 Any legal person or other organization that has conflict of interest with the tenderer and may have impact on fairness of the bidding is not allowed to participate in the bid;
- 3.4 Legal persons or other organizations that are entrusted to participate in the preliminary consultation and bidding documents compiling shall not participate in the bidding, nor shall they provide consultation or bid documents compiling;
- 3.5 Different units have been controlled or managed by same person, they shall not participate in the bidding for the same project;
- 3.6 Only those suppliers who are legally and financially independent of the tenderer and the tendering agency can participate in the project bidding;
- 3.7 The tenderer shall complete the registration and verification of the information on the electronic trading platform for bidding and tendering of mechanical and electrical products (hereinafter referred to as "bidding network", url: <http://www.chinabidding.com>) prior to the deadline set out in the tendering documents, otherwise the tenderer shall be unable to enter the bidding procedure, and the consequences arising therefrom shall be borne by himself;
- 3.8 The goods provided by the bidder must be produced or assembled and commissioned in qualified countries/regions of origin;
- 3.9 The tenderer shall provide the audited financial statements and audit reports for the last three years (2016, 2017, 2018), and, if the law of the country where the bidder is located does not require, shall provide the financial statements acceptable to the tenderer, and shall reflect the financial situation of the bidder, and the bidder shall not lose money for three consecutive years;
- 3.10 The total turnover of the bidder in the last three years (2016-2018) shall not be less than 420 million Yuan or its equivalent in foreign currency (converted according to the cash selling price first issued by the Bank of China on the date of the bidding announcement);
- 3.11. The bidder shall have the supply performance of an automatic fare collection (AFC) system in the urban rail transit project that has been put into operation from September 1, 2014 to the deadline for bidding for this project in the qualified source country/region.
- 3.12. The AFC Clearing Center system (ACC) cast by the bidder must have an application performance of the AFC Clearing Center system (ACC) for urban rail transit from September 1, 2014 to the deadline for bidding for this project within the qualified source country/region.
- 3.13. If the bidder's ACC system is not developed by the bidder itself, it must have the original

special authorization for the project issued by the bidder's ACC system integration service provider.

- 3.14. The key equipment (server, switch, touch screen, banknote processing module, banknote change module, coin processing module, one-way ticket processing module, one-way ticket recovery module, main control unit (ECU), door, passenger traffic monitoring unit, gate and ticket vending machine) in the AFC system tendered by the bidder are not produced by the bidder itself, and must have the original special authorization letter issued by the manufacturer for this project.
- 3.15. The gate machine and ticket vending machine equipment tendered by the bidder must have at least one application performance of urban rail transit;
- 3.16. 3.16. Domestic bidders must also pass CMMI/CMM Level 3 and above certification, and have the same qualifications for overseas bidders.
- 3.17. The consortium bid is not accepted for this project.

Note:

- 1) Application performance refers to the bidder's sales performance or non-bidder's sales performance.
- 2) Urban rail transit is limited to the urban subway system.
- 3) The performance completed by the bidder as a subcontractor or non-consortium lead cannot be regarded as effective performance.
- 4) The above performance shall be provided with scanned copies or photocopies of the main contents of the contract agreement or the contract agreement (including at least the contract amount, equipment list, signature page and key contents) and the performance of providing AFC system shall also include user certificates with official seals issued by rail companies (including subordinate molecular companies). Any performance without valid certificates shall be deemed as invalid.

#### **4. Selling price of tendering documents**

The bidding documents are priced at 3,000 Yuan or 500 U.S. dollars and will not be returned after sale.

**Note: The bidder must remit the money from the account of your own when remittance, and indicate the name of the project participated. Otherwise, the bidder will bear the consequences of invalid bidding due to non conforming name of the bidder or unclear purpose of the payment.**

#### **5. Time of buying tendering documents**

From Sep 25 2019 to Nov 8 2019, 9:30am-11:30am, 13:30-16:30 (Beijing time, Limited to all working days).

Mail order: if needing mail-order, the postage should be paid (EMS fee 200 yuan for the domestic post, while pay another 20 US dollars for the foreign post). Please remit the price and mailing fee of the bidding documents according to the address listed following by Guoxin Tendering Group Co., Ltd. The purpose of the remittance and the number of the bidding documents purchased should be indicated on the remittance slip. Then the copy of the remittance slip, the name of the purchaser, the detailed communication address, postal code, telephone number, fax and contact name shall be faxed to Guoxin Tendering Group Co., Ltd. After that, Guoxin Tendering Group Co., Ltd will send the bidding documents to you by express delivery as soon as possible upon receipt of the fax.

## **7. Deadline of bidding and time of bid opening**

At 9:30am in Nov 11 2019 (Beijing Time). The tender documents which are delivered late or not sealed according to the requirements of the tendering documents shall not be accepted.

## **8. Submission of bidding documents**

The bid documents shall be sealed and delivered to the palace of bid opening before the submission deadline. Overdue submissions or bidding documents which is not according to the requirements will not be accepted. Please send Bidders representatives to participate in the bid opening ceremony.
