The People's Republic of China has received the Joan from the New Development Bank (NDB) toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project and it intends to apply part of the proceeds of this loan to payments under the Contract for Construction of Collecting and Distributing Roads, including Latitude 51th road, BW13 road and east extension section of Latitude 8th Road.

1. <u>COC International Tendering Co. Ltd (Hereinafter referred to as 'Agent')</u> commissioned by the <u>Lanzhou New Area Foreign Fund Project Management Office</u> (Hereinafter referred to as 'Employer'), now invites sealed bids from all eligible and qualified bidders for the construction and completion of the following works.

Newly built Latitude 51th road and BW13 road, with a total length of 3985.15 meters, of which Latitude 51th road length is 2852.264 meters, BW13 road length is 1399.883 meters, road width is 32 meters, and 10 meters green belts are set on both sides of the road. Supporting the construction of lighting, greening and transportation facilities. The starting point of Latitude 51th Road is connected with the already built BW3 Road. The end point is to build the 201 Provincial Road and build 3 new culverts. The starting point of BW13 Road is connected with the planned Latitude 53th road, and the end point is to the built freight yard North Road. Newly built 2 culverts. Newly built east extension section of Latitude 8th Road. The starting point is located at the Longitude 15th road, and the end point is connected with the already built weft road. The total length of the road is 2761.75 meters and the width of the road is 60 meters. There are 20 meters wide urban green belts on both sides. The project will lay 17539 meters of water pipes (10097 meters of green water supply), 9599 meters of rainwater pipes (including connecting pipes), and 6880 meters of sewage pipes, supporting road lighting, greening and traffic facilities.

The estimated completion period is 20 months.

- 2. Bidding will be conducted through the Member States Competitive Bidding procedures. The bidding is open to all bidders from Eligible Sources Countries as defined in the Procurement Guidelines of New Development Bank (NDB).
- 3. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
- 4. The bidder's eligibility requirements include:
- 1) Domestic bidders must have first-class and above qualifications for municipal public works construction general contracting issued by the Ministry of Construction; Equivalent qualifications are needed for foreign bidders.
- 2) The bidding does not accept Joint Venture bid.
- 3) In the past three years (2016-2018), the audited financial report proved that the average annual turnover reached CNY400 million or an equivalent amount in a freely convertible currency;
- 4) The bidder's financial resources (such as quick-moving assets, credit lines and other sources of financing, excluding contractual advances) must be able to meet: (1) A cash flow requirement of CNY40 million or an equivalent amount in a freely convertible currency; (2) The total cash flow requirements required to implement this contract and other projects under construction.
- 5) The bidder shall be the contractor in the past 5 years (August 2014-August 2019) successfully undertaken at least two construction contracts of similar scale and complexity, and each contract amount is not less than CNY220 million or an equivalent amount in a freely convertible currency, based on the notice of winning the bid or the contract or completion acceptance certificate;
- 6) The project manager who participates in the project construction shall have at least 10 years of construction experience and 5 years of experience as a similar project manager in the project with the same nature and scale of the project, and have the qualification of the municipal public works first-class registered architect. Senior or above technical title. The chief engineer of the project must have the qualification of a first-class registered construction engineer in municipal public works, senior and above titles, and should have at least 10 years of construction experience and 5 years of experience as a chief engineer of similar projects. Equivalent qualifications are needed for project manager and chief engineer of foreign bidders.
- 5. Bids must be delivered to the address below at or before 10:30 am, October 31, 2019. Late bids will be rejected. Bids will be opened in the presence of the bidders'

representatives who choose to attend in person at the address below at <u>10:30 am,</u> <u>October 31, 2019</u>. All bids must be accompanied by a bid security of <u>CNY2,600,000</u> or an equivalent amount in a freely convertible currency.

- 6. In the past five years (October, 2014-September, 2019), bidders who are declared unqualified by Chinese governments at all levels, by members of the New Development Bank and other international financial organizations recognized by NDB are not allowed to participate in bidding.
- 7. Individuals or enterprises listed by the judicial department as dishonest persons or with other dishonest acts (including enterprise whose legal representatives, principal persons in charge, actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall be restricted to participate in government investment projects or the projects that mainly use public finance. They are restricted to engage in the development and utilization of real estate resources such as land and minerals, to participate in the transaction of state-owned property rights such as state-owned enterprises' assets and state assets, and to participate in the centralized procurement of drugs and medical consumables and the sunshine procurement activities. If a person who is dishonest participates in the transaction of public resources, the bid evaluation committee shall disqualify him or her or cancel the bidding directly. (This project will abide by this clause, and the unfinished matters shall be interpreted by the purchaser)
