## **1.Bidding Conditions**

Overview: Luoyang urban rail transit line 1 project will be laid on the ground. There is a transfer station for Line 2, Line 3 and Line 4 in the planning network. The west end of the line is equipped with Hongshan vehicle base, which connects with Hongshan station. In the east, a parking lot will be set up to connect with Yangwan Station. Type B vehicles are selected, and the trains are grouped into six groups in the initial, short-term and long-term.

Source of Funds: The construction funds for this project is from the New Development Bank loan and the Chinese government allocations. The tenderer has acquired purchase funds and will ensure the smooth implementation of various contracts under this project.

Description of The Prepared Bidding Conditions: Luoyang Urban Rail Transit Line # 1 project has been approved for construction by Henan Development and Reform Commission with the approval document of Henan Development and Reform City [2017] No.667.

Qualifications or Performance: 3.1 The bidder is a legal person or other organization that responded to the bidding, purchased the bidding documents from the bidding agency and participated in the bidding competition. Any legal person or other organization that has not purchased the bidding documents from the bidding agency is not allowed to participate in the bidding; 3.2 Any legal person or other organization from member countries of New Development Bank (hereinafter referred to as "qualified countries of origin" ) may participate in the bidding; 3.3 Any legal person or other organization that has conflict of interest with the tenderer and may have impact on fairness of the bidding is not allowed to participate in the bid; 3.4 Legal persons or other organizations that are

entrusted to participate in the preliminary consultation and bidding documents compiling shall not participate in the bidding, nor shall they provide consultation or bid documents compiling; 3.5 Different units have been controlled or managed by same person, they shall not participate in the bidding for the same project; 3.6 Only those suppliers who are legally and financially independent of the tenderer and the tendering agency can participate in the project bidding; 3.7 The tenderer shall complete the registration(Free) and verification of the information on the electronic trading platform for bidding and tendering of mechanical and electrical products (hereinafter referred to as "bidding network", url: <http://www.chinabidding.com>) prior to the deadline set out in the tendering documents, otherwise the tenderer shall be unable to enter the bidding procedure, and the consequences arising therefrom shall be borne by himself; 3.8 The goods provided by the bidder must be produced or assembled and commissioned in qualified countries/regions of origin; 3.9 The tenderer shall provide the audited financial statements and audit reports for the last three years (2016, 2017, 2018), and, if the law of the country where the bidder is located does not require, shall provide the financial statements acceptable to the tenderer, and shall reflect the financial situation of the bidder, and the bidder is not lose money for three consecutive years; 3.10 The total turnover of the bidder in the last three years (2016-2018) shall not be less than 81 million Yuan or its equivalent in foreign currency (converted according to the cash selling price first issued by the Bank of China on the date of the bidding announcement); 3.11 The bidder shall be the manufacturer of at least one brand of channel type X-ray safety inspection equipment; 3.12 If the bidder's bench-type liquid detector, portable liquid detector and portable explosive detector are not made by the bidder, the special authorization letter issued by the manufacturer of the above-mentioned equipment or the agent in China for this project shall be obtained; 3.13.The bidder must have a similar project performance; 3.14 The consortium bid is not accepted for this project. Note: 1) The performance of similar projects in this project is limited

to qualified source countries / regions. Supply performance of the technology protection security inspection items in the urban rail transit project has been put into operation from June 1, 2014 to the deadline for bidding of the project. 2) Urban rail transit is limited to the urban subway system. 3) The performance completed by the bidder as a subcontractor or non-consortium lead cannot be regarded as effective performance. 4) The above performance shall be provided with scanned copies or photocopies of the main contents of the contract agreement or the contract agreement (including at least the contract amount, equipment list, signature page and key contents) and user certificates with official seals issued by rail companies (including subordinate molecular companies). Any performance without valid certificates shall be deemed as invalid.
