

# Chapter I Invitation for Bids

## **Invitation for Bids for the Second Batch of 15MWp PV Modules of the New Photovoltaic Power Generation Project in 2020**

(Tender No.: CZ 2020-357)

Project location: Shanghai

### **I. Bidding Conditions**

The Second Batch of 15MWp PV Modules of the New Photovoltaic Power Generation Project in 2020 has been approved by the project examination/approval/filing authorities. The self-raised project fund is RMB 26.25 million. The Tenderer is Shanghai Lingang Hongbo New Energy Development Co., Ltd. The Project is ready for bidding and now is open for **public bidding for eligible bidders from NDB member countries.**

### **II. Project Overview**

Scale: The People's Republic of China has received the loan from the New Development Bank (NDB) toward the cost of "Lingang Distributed Solar Power Project" and it intends to apply part of the proceeds of this loan to payments under the Contract for "Second Batch of 15MWp PV Modules of the New Photovoltaic Power Generation Project in 2020". 1. Bid substance: (1) The Second Batch of 15MWp PV Modules of the New Photovoltaic Power Generation Project in 2020. The specification of the single module is monocrystalline silicon PERC double-sided double-glass module, with a capacity of not lower than 365Wp and a total capacity of 15MWp. 2. Bidding scope: supply, transport and technical guidance for installation of the Second Batch of 15MWp PV Modules of the New Photovoltaic Power Generation Project in 2020. Refer to the "Technical Specifications and Requirements" of the bidding document for details. 3. Date of delivery: the goods shall be transported to the designated location and installed under supervision within 60 calendar days after the advertisement contract is signed (which shall be subject to the actual batch

of the Project, and the delivery term of single batch shall be 15 days after receiving the order from the Tenderee). 4. Warranty period: 10-year warranty for limited products, and 25-year warranty for limited power output. 5. Maximum bid price: RMB 26.25 million.

Scope: The tender project has one lot, in which:

### **III. Qualification Requirements of Bidders**

1. Qualifications: The Bidders must be the enterprises with an independent legal personality and have the business license verified and issued by the industrial and commercial administrative department with corresponding business scope of the tender project;
2. The Bidders must be the manufacturers of PV modules;
3. The bidding products must be CQC or CGC certified;
4. The Bidders must have the ISO9001 quality management system certificate;

The bidding of the Consortium is not accepted for the Project.

5. In good financial condition, capable of performing the contract, operating in compliance with the law, and not subject to legal sanction due to the problem of good faith; Have good commercial credit and industry reputation;
6. Relevant performance of photovoltaic modules since January 1, 2017;
7. The bidder shall undertake that the bid is not prohibited by the Chinese governments at all levels, NDB members and other NDB international financial organizations.

Consortium bidders are not accepted for the Project.
