1. The Chinese government has obtained a loan from the New Development Bank to pay for Jiangxi Natural Gas Transmission System Development Project (18CN04) and plans to use part of the loan to pay for the qualified expenses under the Jiangxi Provincial Natural Gas Pipeline Network Project Phase I Leping-Dexing-Wuyuan Yongxiu-Wuning-Xiushui Branches Seamless Steel Pipes Procurement- Rebidding (JX-TRQ-YX-G03). Bidding is open to eligible Bidders from member countries of New Development Bank.
2. Minmetals International Tendering Co., Ltd. (hereinafter referred to as “Procurement Agent”) was entrusted by the purchaser Jiangxi Provincial Natural Gas Group Co., Ltd. Pipeline Branch, and now invites qualified bidders to submit a sealed bid for Seamless Steel Pipes.

4. Qualification Requirements for Bidder

- 4.1. The bidder shall be legally registered in any new development bank member country, have the qualification to sign the contract independently, and be the manufacturer of the bidding goods, and the sales company directly under the manufacturer group shall be deemed as the

manufacturer;

4. 2. From January 1st, 2017 to the deadline for submission of bids, the bidder shall have at least one (1) contract of supply domestically or overseas of oil and gas transmission pipeline of 3PE corrosion-resistant seamless steel pipe with a ϕ 219 and above specifications;

4. 3. Financial requirements

The bidder shall provide the audit reports of the last three years (2017, 2018, 2019), or, shall provide the financial statements acceptable to the purchaser, reflecting the bidder's financial position, if not required by the laws of the bidder's country. The bidder shall meet the requirements of 1), 2) and 3) below.

- 1) the bidder shall satisfy that the difference between total assets and total liabilities for the last years (2019) should be positive.
- 2) the bidder shall satisfy that the ratio of current assets to current liabilities in each of the last three years shall not be less than 1;
- 3) the average annual turnover of the bidder in the last three years shall not be less than CNY 10 million or equivalent foreign currency.
