

# **Invitation for Bids**

## **Development of Water Supply and Sanitation Systems Project**

### **Contract No. DWSP/ICB/DZR-1**

1. This Invitation for bids follows the general procurement notice for this project that appeared on the Web-site of the New Development Bank (NDB) on July 18, 2019.
2. The Russian Federation has received a loan from the New Development Bank towards the cost of a Development of Water Supply and Sanitation Systems Project and it intends to apply part of the proceeds of this loan to payments under the Contract No. DWSP/ICB/DZR-1 comprising of three subprojects:
  - Construction of the second pipeline of Teplovsky water intake structure;
  - Construction of water pipeline to Pyra village;
  - Construction of main sewage header.
3. Representative Office of the Saint-Petersburg Foundation for Investment Projects (FISP) in Moscow, acting on behalf of the Ministry of Construction, Housing and Utilities of the Russian Federation, as the Project Implementation Unit (PIU) now invites sealed bids from eligible bidders for procurement of works for the Contract No. DWSP/ICB/DZR-1, which include procurement of equipment, construction and installation works, testing and commissioning of works.
4. Bidding will be conducted through the international competitive bidding procedures in line with the New Development Bank Procurement policy published on March 28, 2016, (revised in March, 2018), and is open to all bidders from eligible source countries as defined in the Procurement policy.
5. Interested eligible bidders may obtain further information from the Saint-Petersburg Foundation for Investment Projects (FISP), Representative Office in Moscow and inspect the bidding documents at the address given below workdays from 10.00 hours till 17.00 hours.
6. To participate in the bidding prospective bidders shall submit a written application to the address given below and receive a complete set of the bidding documents in the English or Russian language.
7. On December 14, 2020, from 11:00 to 11:30, bidders will submit their bids electronically with their further submission the original bid in hard copy. The original Bid including the original of bid security in the amount of RUR 40 000 000 or an equivalent amount in other BRICS member country currency in hard copy must be delivered within three days after the bid submission date from 10:00 to 17:00, Moscow time at the address:
