

Invitation For Bids

Procurement of Rolling Stocks

Hubei Huangshi Modern Tram Project

Financed by NDB

1. Conditions for Tender

The Government of People's Republic of China has applied for use of NDB loan for Hubei Huangshi Modern Tram Project (loan No. 19N05).

The tender is open to eligible bidders of NDB member countries.

The tender for procurement of rolling stock (package G-01) pertaining to Hubei Huangshi Modern Tram Project financed by NDB has been approved by the Hubei Huangshi Municipal Government, and the tenderer is Huangshi Railway Construction and Investment Co., Ltd. The investment amount for the rolling stock supply and service procurement package G-01 is 624 million RMB Yuan. Now the conditions for tender have been met and bids are hereby invited publicly.

2. Name and Quantity of Goods under the Tender

All rolling stocks under the tender shall be manufactured in China by the bidder, whilst the localization rate of rolling stock shall not be lower than 75%.

The bid will be evaluated and contract awarded as per contract package, where bidders must submit bids as per the above contract package and bids for only part of goods or services in the contract package will be rejected. With regard to the specific scope of supply and services including the rolling stocks, spare parts, wear parts, consumables, technical documents and training as well as maintenance, please refer to Volume II of the tender

documents for detailed contents, requirements and specifications.

3. Qualification Requirement for Bidders

- (1) The tender is open to bidders registered in NDB member countries; all eligible bidders of NDB countries are allowed to bid. Bidders in P. R. China must be rolling stock manufacturers of independent legal entity that are qualified for manufacture of rolling stocks in accordance with Chinese urban rail vehicle policies and are capable of supply of goods and services under the tender.
- (2) At least one supply reference experience for 100% low floor steel wheel steel rail modern tram project.
- (3) A bidder must bid in the form of general contractor and shall be responsible for the technology and all related interfaces of the vehicle components subcontractors. The goods to be supplied by the bidder must be technically mature, functionally complete, operationally safe and reliable.
- (4) This tender does not accept bids in form of joint venture.

A documentation fee of RMB500 Yuan shall be paid on the occasion of bid opening.
