1. The People's Republic of China has obtained the loan from the New Development Bank (NDB) toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project (Loan No.:19CN04) and it intends to apply part of the proceeds of this loan to the payments under the Contract for Multimodal Transport Logistics Information Platform Construction.

2. COC International Tendering Co. Ltd (Hereinafter referred to as "agent") delegated by Lanzhou New Area Foreign Fund Project Management Office (Hereinafter referred to as "Client"), now invites sealed bids from all eligible and qualified bidders for the construction and completion of the following works.

This project consists of one component, collectively referred to as the Multimodal Transport Logistics Information Platform Project (hereinafter referred to as "information construction").

The main project content of information construction: a cloud platform, an application system platform, a support system, and auxiliary works.

The cloud platform includes the construction of data center basic platform, cloud computing resource center platform, big data basic platform, and disaster recovery center platform.

The application system platform includes: 4 system platforms including logistics service platform, supply chain service platform, smart park management platform, electronic port platform as well as transportation management system, warehouse management system, intra-city

distribution system, multimodal logistics supply chain system, supply chain finance service system, fleet management system, freight forwarding management system, public logistics information system, centralized command and monitoring center, integrated multimodal transportation information management platform, customs clearance facilitation system, smart bayonet management system, smart station management system, driver end system , employee smart terminal APP, park storage management system, diversion guidance system, clearing and settlement system, big data analysis system, electronic port service system.

Supporting systems include: network system, wireless network system, information security system, data exchange and access system.

Auxiliary works include: park office hall works, park monitoring center works, integrated wiring works, computer room supporting works.

Project specific construction site and content

For specific technical parameters and procurement list, please refer to Chapter 9 “Goods Demand Sheet” of the Tendering Document.

The estimated construction period of the above project is 24 months, and the system operation period is 12 months, totaling 36 months (it can be completed ahead of schedule).

3. This bidding will be conducted through the Member Countries Competitive Bidding procedures. The bidding is open to all bidders from Eligible Member Countries as defined in the Procurement Guidelines of New Development Bank (NDB).

4. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Tendering Documents. All Bidders found to have a conflict of interest shall be disqualified.

5. Qualifications requirements of the bidder include:

(1) Domestic bidders must be registered and obtained a business license in the People's Republic of China, have independent legal personality, have the capability of assuming independently civil liability, and have the business scope required to complete the project (provide copies of relevant certificates with official seals). Foreign bidders must have equivalent qualifications.

(2) In the past three years (2017-2019), the audited financial report proved that the average annual turnover should be no less than CNY 30 million or an equivalent amount in a freely convertible currency. Equivalent qualifications are needed for foreign bidders.

(3) The bidder's financial resources (such as quick-moving assets, credit lines and other sources of financing, excluding contractual advances) must be able to meet: (1) A cash flow requirement of CNY 20 million or an equivalent amount in a freely convertible currency; (2) The total cash flow requirements required to implement this contract and other projects under construction. Equivalent qualifications are needed for foreign bidders.

(4) The bidder shall have successfully undertaken at least two contracts of similar scale and complexity in the past 5 years (December 2015 to December 2020), and the amount of each contract shall be not less than the equivalent of CNY 20 million based on the bid winning notice or contract or agreement or the completion acceptance certificate or other valid proof (not less than two proof documents, copies are required, including front page, amount page, buyer and seller's names and seals; the original documents will be checked if necessary). Equivalent performance certification documents are needed for foreign bidders.

(5) All bids must be accompanied by a bid security (CNY 1,000,000.00) or guarantee for the equivalent amount in a freely convertible currency.

(6) This bidding does not accept Joint Venture bid.

6. In the past five years (December 2015- December 2020), bidders who are declared unqualified by Chinese governments at all levels, by member countries of the New Development Bank and by New Development Bank are not allowed to participate in the bidding.

7. The bidder shall have no record of bad behavior on the Credit China website (<http://www.creditchina.gov.cn/>) (Enquiry screenshots must be provided).

9. Access to the tender documents.

(1) The public can download or view the bidding procurement documents for free through the Gansu Provincial Public Resources Trading Network. Potential bidders who intend to participate in public resources trading activities in Gansu Province need to register on the Gansu Public

Resources Trading Website first. Please log in by using "user name + password + authentication code" or CA digital authentication. After that, they can download or read the bidding documents from the internet and engage in follow-up activities such as registration (for detailed information, please see tendering documents)

(the publication time is $n * 24$ hours, $n \geq 5$ days for the publication of tender documents in accordance with relevant national regulations).

(4) Affected by the epidemic of the COVID-19, the bidding activity of Multimodal Transport Logistics Information Platform Construction of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project will be conducted through the Online Bid Evaluation System of Gansu Provincial Public Resources Trading Bureau (<http://121.41.35.55:3010/OpenTender/login>). The bidders are required to log in the system mentioned above before the bid opening time, and download following items: bidding document curing tool, guidance of online bid evaluation system and cured bidding document. By following the guidance of online bid evaluation system, the bidders should solidify the bid documents and complete online bidding (upload the file HASH code of the solidified bid document) and the bid opening operation. If there is without online bidding process before the bid opening deadline (upload the file HASH code of the solidified bid document),it is deemed that the bid is abandoned.
