

- 1 The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to bidders to qualify for the award of the contract and also inspect the site before bidding.
- 2 Time allowed for completion of each package is 12 months, including rainy season.

- 8 Instrument of Bid Security (as specified in the bidding document) of the amount specified for the work in the table shall be valid for 45 days beyond the validity of the bid. Scanned copy of the instrument of this affidavit shall be submitted on-line as part of Contractor's documents.
- 9 Each bidder is required to furnish an affidavit giving information on prescribed Performa Section-3 Qualification Information of the Bidders required for evaluation of the bidding capacity of the bidder. Scanned cop of this affidavit shall be submitted on-line as part of Contractor's document.
