The Chinese government has obtained a loan from the New Development Bank to pay for Jiangxi Natural Gas Transmission System Development Project (18CN04) and plans to use part of the loan to pay for the qualified expenses under the Jiangxi Provincial Natural Gas Pipeline Network Project Wanzai-Tonggu Branch Steel Pipes Procurement (JX-TRQ-GF-G13).
2. Minmetals International Tendering Co., Ltd. (hereinafter referred to as "Procurement Agent") was entrusted by the purchaser Jiangxi Provincial Natural Gas Group Co., Ltd. Pipeline Branch, and now invites qualified bidders to submit a sealed bid for Seamless Steel Pipes.
3. Open bidding will be conducted and is open to eligible Bidders from member countries of NDB.

4. Goods and quantity to be purchased as follows:

1) Contains 3PE anti-corrosion processing, does not contain FRP anti-corrosion. 2) The settlement method is based on the actual weighing weight, and the unit price is the comprehensive unit price of anti-corrosion and bare pipe.					

5. Qualification Requirements for Bidder
  - 5.1. The bidder shall be legally registered in any new development bank member country, have the qualification to sign the contract independently, and be the manufacturer of the bidding goods, and the sales company directly under the manufacturer group shall be deemed as the manufacturer.
  - 5.2. Bidders from January 1, 2018, to the deadline for bidding, the bidder shall have at least one 3PE anticorrosive seamless steel pipe supply performance of oil and gas transportation pipelines with specifications above  $\phi 323.9$ .
  - 5.3. The anti-corrosion unit entrusted by the bidder shall have at least one 3PE anti-corrosion processing performance of seamless steel pipe with specifications above  $\phi 323.9$  from January 1, 2018, to the deadline for bidding.
  - 5.4. Financial requirements  
The bidder shall provide the audit reports of the last three years or, if not required by the country in which they are located, financial statements that demonstrate a stable financial position. As a minimum requirement, bidders should meet.

- 1) the bidder shall satisfy that the difference between total assets and total liabilities for the last years should be positive.
  - 2) The ratio of current assets to current liabilities of the bidder in each of the last three (3) years shall not be less than 1 (the bidder with current ratio less than 1 shall provide bank credit or credit line from bank with no less than CNY12.5 million or equivalent foreign currency for this project;
  - 3) the average annual turnover of the bidder in the last three years shall not be less than CNY 100 million or equivalent foreign currency.
- 5.5. All pending litigation, counted as lost litigation, shall represent in total of the last five (5) years not more than fifty percent (50%) of the Bidder's net worth.

5.6. Bidders must have legal qualifications.

5.7. The project does not accept the form of a joint venture.

5.8. Additional details are provided in the Bidding Documents.
