- Bidder shall required to deposit of Tender Document Fees/RISL bid processing fees to follow procedure as suggested below:-
  - Bidders are required to register as registered user on egras web portal.
  - Create profile with Department (214 water resources department(CE, Hanumangarh) for separate challan payments for Tender Document Fees /RISL bid processing fees ) paid separately.

- 6- The Tender cost and RISL bid processing fees in a single or separate e-challan shall be in favour of **Executive Engineer, Water Resources North Division SriGanganagar(Division Code-701) DDO-CODE-683.**



- 7- The bid security deceleration form shall be address to **Executive Engineer, Water Resources North Division SriGanganagar**
- 8- The bid not uploaded in prescribed form will be rejected without mentioning any reason.
- 9- All pages and schedules of original bid supporting documents should be essentially filled in and should be signed on each page by the bidder or his authorized representative.
- 10- Online Bid will be received and opened on dates mentioned above by the Bid evaluation committee or by an officer authorized in presence of intending bidders or their authorized representatives.
- 11- No physical/off-line Bid shall be accepted in any case.
- 12- The bid shall be valid for 120 days from the date fixed for bid submission deadline.
- 13- The Department reserves right to reject any or all Bids or to accept them in part, without assigning any reason thereof.
