The construction content includes new construction (structures) buildings, auxiliary facilities, auxiliary road construction, equipment procurement, installation and commissioning (including equipment and processing commissioning), etc., original Ganlin town WWTP to the newly built WWTP sewage pipes connection and structures within the ancillary equipment form a complete set of piping and valves and other accessories, all electrical, control and instrumentation and monitoring equipment and button box, as well as the equipment connection cable, fiber optic cable laying of the trough and pipes and so on all belongs to the scope of the tendering, which shall be supplied and installed by the equipment supplier.</p> <p>The bidder shall provide but not limited to the accessories required within the scope of the project.
