The People's Republic of China has applied for financing in the amount of EUR 265 million from the New Development Bank (hereinafter NDB) toward the cost of Lanzhou Zhongchuan International Airport Phase III Expansion Project and it intends to apply part of the proceeds to payments for equipment and system components to be procured under this project.

The Loan will be utilized to finance procurement of equipment and system components for the Project. The equipment and system components are broadly classified into following major categories: (i) baggage handling & security system; (ii) passenger boarding bridges; (iii) power supply equipment; (iv) refrigeration and heat exchange process equipment; (v) airport utility vehicles; (vi) heating and ventilation air conditioning system; (vii) dimmers and related types of equipment and materials; (viii) aircraft ground air conditioning; etc.

The procurement for NDB financed contracts will be carried out following the country procurement systems which is found materially in compliance with NDB's Procurement Policy. The applicable country system procurement laws are the

Chinese Tendering and Bidding Law, Government Procurement Law, Implementing Regulations on the Tendering and Bidding Law of China, Implementing Regulations on the Government Procurement Law of China, and Measures for the Administration of Tendering for Civil Aviation Professional Engineering Construction Projects.

Procurement of contracts financed by NDB will be open to its member countries as requested by its Procurement Policy, some certain specialized equipment and system components will be carried out using competitive bidding open to global market, including NDB non-member countries.

Specific procurement notices for contracts subject to open competitive bidding will be announced, when they become available, All bidding invitations will be published on the NDB website, NDRC website of public tendering and bidding service platform (www.cebpubservice.com), and where applicable on Civil Aviation Engineering Construction Project Tendering and Bidding Management System (<https://zbtb.caac.gov.cn>), Social Public Resources Trading Centre Project Trading Platform, and Ministry of Commerce bidding website (www.chinabidding.com).
