The People's Republic of China has received a loan from New Development Bank (hereinafter called "NDB") toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project and it intends to apply part of the proceeds of this loan to the payments under the Contract for the Civil Works of Road Construction of Jing No. 7 Road Northern Extension Section (From Wei No. 24 Road to Wei No.28 Road)

1. COC International Construction Consulting Group Co. Ltd. (hereinafter called "Bidding Agency") entrusted by the Lanzhou New Area Foreign Fund Project Management Office (hereinafter called "Client") to invite all the qualified bidders to submit sealed bids for the following constructions:

The new - constructed road starts from the existing Wei No. 28 road. It will intersect with Wei No. 26 circuit branch and Wei No. 26 road and end in connection with the existing Jing No. 7 road. The total length is 1,728.48m and road red line width is 56 m. The design speed is 60km/h. The road is designed to be city trunk road with four cross -section, two-way eight lanes, and asphalt concrete pavement. The major scope of construction includes roads construction, culverts construction, drainage pipes construction, lighting project, and traffic matching infrastructure.

The construction duration is 12 months.

This bidding is National Comparative Bidding. Any qualified bidder who meets NDB Procurement Guideline can submit the bids.

The potential bidders should pay attention to the provisions of the eligibility and conflict of interests required by the ITB 4 of the Bidding

Documents. All the potential bidders found with conflict of interests shall be disqualified.

The bidders' qualification may include the following:

(1). Domestic bidders should have the grade - one qualification or above for municipal public facilities construction general contracting promulgated by Ministry of Housing and Urban & Rural Development. The domestic bidders should have effective production safety permit. Foreign bidders should have the equivalent qualifications.

(2). This contract does not accept joint venture bidding.

(3). For the past three years (2018-2020), the audited financial report can prove that annual minimum construction value should be greater than CNY 190 million or the equivalent value of the convertible currency. Foreign bidders should have the equivalent qualifications.

(4). The financial resources of the bidders, such as quick assets or credits, and other financial sources, but not including the advance payment, should meet the following requirements: (i) cash flow of CNY 19 million or the equivalent should be met; (ii) Total cash flow requirement for implementing this contract and other projects under construction can be met. Foreign bidders shall have the equivalent qualifications.

(5). For the past five years (June 2016-June 2021), the bidder as a contractor should have completed at least two contracts for city trunk roads construction. Each contract value should be no less than CNY 61 million or the equivalent, which can be proved by the awarding notices or acceptance certificates. Foreign bidders should have the equivalent performance documents.

(6). The proposed project manager should have at least eight years of construction experiences and five years of the project manager experiences for the similar projects. He/she should have the qualification of the grade - one registered construction engineer for municipal facilities, technical qualification for senior engineer or above, and the valid production safety certificate. For the past five years (June 2016-June 2021), he/she should undertake at least one contract of municipal road construction project and each single contract value should be no less than CNY 61 million or the equivalent value. General

engineer should have the qualification of the grade - one registered construction engineer for municipal facilities, technical qualification for senior engineer of municipal facilities or above, and eight years of construction experiences and five years of general engineer working experiences for the similar projects. Foreign bidders' project managers or general engineers should have the equivalent qualifications.

2. All bids must include a bid guarantee. The bid guarantee value is one million and five hundred thousand CNY 1,500,000 or the equivalent value of the convertible currency.

3. For the past five years (from June 2016 to June 2021), the bidders should not be declared as "unqualified" by Chinese governments with different levels or ADB member countries. If declared, the bidders may not participate the bidding.

4. Any Individuals or enterprises listed by the justice department as "discredit" or exist discredit activities, the discredited legal representatives, major staff in charge, actual controlling staff, directors, supervisors, and senior managing staff are banned to participate the procurement of this projects in accordance with the relevant laws. If the discredited bidders participate in the procurement of this project, bid evaluation committee may cancel the qualification of this bidder or directly disqualified (the client may explain anything not specified here).

6. Obtain the bidding documents

(1). The public may free to download or search bidding documents through Gansu Province Public Resources Website. Any potential bidders who want to participate Gansu Province public resources trading, please register on Gansu Province Public Resources Website first to obtain "user name + password + verification code". Then, log in with the prescribed procedures or log in with CA. Both methods can process "the bidding" or the subsequent activities (detailed information please see the bidding documents).

(3). Any interested bidders may free to obtain the bidding documents through Gansu Province Public Resources Trading Website. The obtaining time is from 00:00 24 July 2021 to 10:00 18 August 2021.

The deadline for submitting the bids on - line is the time prescribed in the bidding documents or pre - qualification documents (the prescribed time is n * 24 hours, $n \geq 5$ days)

(4). Affected by the pandemic of the COVID-19, bid opening for Civil Works of Road Construction of Jing No. 7 Road Northern Extension Section (From Wei No. 24 Road to Wei No.28 Road) financed by NDB will be changed to the on-line bid opening and evaluation system of Gansu Provincial Public Resources Trading Website (<http://121.41.35.55:3010/OpenTender/login>). The bidders are required to log in the system before the bid opening time, download bids documents confirmation tool, on-line bid opening and evaluation system user's manual, and the confirmed bidding document. Then, confirm your bids based on on-line bid opening and evaluation system user's manual and complete your on-line bids submission (upload the HASH code of the confirmed bids) and operate the bid opening. If there is no on-line bids submission before the deadline (upload the file HASH code of the confirmed bids), it is regarded as "not participating the bidding process". This bidding process adopts the "single-stage and double envelopes".
