

**CURITIBA****BIDDING NOTICE****INTERNACIONAL PUBLIC COMPETITION Nº 028/2023-SMOP/OPP-NDB  
(Tender reference in the Project Procurement Plan is W-004-001)**

THE MUNICIPALITY OF CURITIBA, through the MUNICIPAL SECRETARIAT OF PUBLIC WORKS - SMOP and the MUNICIPAL CITY HALL OF CURITIBA, makes public, for the knowledge of interested parties, that it is promoting a Bidding in the Internacional Public Competition Modality, aiming at the selection and contracting of a company or consortium of companies, from NDB member countries, for the execution of works for the road infrastructure batch 4.1 e batch 4.2.

Financial resources come from the New Development Bank – NDB and the Municipality of Curitiba.

The Value of the Work with BDI amounts to a total of (BRL) R\$ 66.733.611,57 (sixty six million, seven hundred and thirty three thousand, six hundred and eleven reais and fifty seven cents). This bidding will be carried out in national currency (Reais) and payments will be made exclusively in Brazil.

The Work comprises civil engineering services for: Earthworks, paving, drainage, signage, landscaping, fiber optic infrastructure, traffic lights, containment, public lighting and interference relocation.

The Location and scope of the Work comprises two road sections: Mauricio Fruet avenue and street Prof. Olga Balster, and street Des. Mercer Junior, Eng. Costa Barros, Terminal Oficinas, street Filipinas, street Lorival Wendler, street Ceilão, street Nagib da Silva, street Cap. Guilherme Bianchi e street Niteroi (section between Ceilão e Eng. Costa Barros), and renovation and expansion of the terminals Centenário and Vila Oficinas, located in the Municipality of Curitiba - State of Paraná – Brazil.
