

Invitation for Bid

1. Bidding Conditions

The Purchaser of this bidding project (project name: Procurement and Installation for 400HZ static variable power supply device and aircraft ground air conditioning equipment of Hohhot New Airport financed by New Development Bank Loan) is Hohhot Airport Construction Management Investment Co. Ltd. The fund for the bidding project is from loans of New Development Bank and financial supporting funds (fund source), the contribution ratio is 80% from New Development Bank loan and 20% from financial matching funds. The project has already met the Bidding Conditions, and now procurement and installation for 400HZ static variable power supply device and aircraft ground air conditioning equipment is subject to public bidding.

2. Project Overview and Bidding Scope

2.1 Project Name: Procurement and Installation for 400HZ static variable power supply device and aircraft ground air conditioning equipment of Hohhot New Airport financed by New Development Bank Loan;

2.2 Bidding Scope: The scope of this bidding includes 102 sets of 400HZ static power supply devices (66 sets of bridge mounted and 36 sets of mobile) and 56 aircraft ground air conditioners at Hohhot New Airport

The bidder shall provide all equipment, systems, component materials, equipment accessories, and spare parts, testing and special tools required for operation and maintenance within the scope of this bidding; Complete the design, design liaison, equipment design selection, manufacturing procurement, supervision, inspection, factory acceptance, transportation, warehousing, unpacking inspection, installation, interface coordination, test debugging, cooperation acceptance (including engineering acceptance, government department acceptance, etc.) of all equipment in the project, cooperate with the operation unit for assessment, training, trial operation, submit relevant documents and drawings, draw completion drawings, complete handover to the End-user, and technical support during critical periods, services within the specified period including warranty, maintenance, training, return-visit and technical consulting. See details in Chapter V “Requirements for Supply of Goods”;

2.3 Delivery Place: Designated place at construction site of Hohhot New Airport, Qiaoshiying Town, Helingeer County, Hohhot City;

2.4 delivery time: All equipment should at the latest be arrived by April 30, 2024 , complete installation and commissioning by August 30, 2024, and meet the completion conditions by October 30, 2024.

3. Qualification Requirements for Bidder

3.1 The bidder shall be the manufacturer or authorized agent of the equipment being proposed (only one agent authorized by manufacturer for equipment of the same brand and model is allowed.

If manufacturers authorize more than one agent to participate in the bidding for equipment of the same brand and model, the bid of the involved agent shall be invalid);

3.2 The bidder shall be from member country of the New Development Bank (including Brazil, Russia, India, China, South Africa, Bangladesh, Egypt and United Arab Emirates (UAE), and the other member countries formal joined the New Development Bank before the deadline for bid submission), and not sanctioned or prohibited from bidding by the government at all levels of the member country of New Development Bank;

3.3 Equipment proposed to be supplied by bidder shall be notified in “Special equipment management system of civil airport” on the website of Civil Aviation Administration of China with status of “normal”;

3.4 The bidder shall provide at least one equipment supply contract for 400HZ aircraft ground static power supply and aircraft ground air conditioning for civil aviation airports in the past five years (from January 1, 2018 to the present, defined by the date of contract signature), the brand shall be the same as the equipment brand proposed for this bidding;

3.5 The bidder’s net profit of each year in past 3 years (2020, 2021 and 2022) shall be positive;

3.6 Domestic bidder shall not be included into the list of dishonest persons subject to enforcement by the website of "Credit China" (www.creditchina.gov.cn/) or "China Executive Information Disclosure Network" (<http://zxgk.court.gov.cn/>);

3.7 Different entities with the same person in charge or with holding or management relationship shall not participate in the bidding of this project at the same time;

3.8 Bid by Joint Venture is not accepted for this bidding.

4. Bidding Registration

4.1 The bidder shall make bid registration in Civil Aviation Engineering Construction Project Tendering and Bidding Management System (<http://zbtb.caac.gov.cn/>) with registration data or send the electronic version of the scanned copy of the registration data to liwenduo@minmetals.com for bid registration during the period from 2023-11-06 09:00:00 to 2023-11-16 17:00:00 (except public holidays and legal holidays).

The registration data includes ① business license or registration certificate; ② identity certificate of the legal representative or power of attorney; ③ ID card and contact information (including name, telephone number, email, address, etc.) of the agent. All above documents shall be affixed with official seal.

Note: The bidder shall complete registration online in Civil Aviation Engineering Construction Project Tendering and Bidding Management System (<http://zbtb.caac.gov.cn/>).

5. Acquisition of Bidding Documents

The Purchaser will send the Bidding Documents within 2 days after receiving the company introduction letter, courier order payment, and technical documents deposit (including service charge).

5.1 (B) Any potential bidders who want to participate in the bidding shall log in the Civil Aviation Engineering Construction Project Tendering and Bidding Management System to download the electronic Bidding Documents during the period from 2023-11-06 09:00:00 to 2023-11-16 17:00:00 (Beijing time, the same below).

5.2 The price for each set of Bidding Documents is RMB 1,000 or USD 150 and it is non-refundable.

6. submission of bid

6.1 The deadline for submission of bid (deadline for bid, the same below) is 2023-12-07 14:00:00, and the place is bid opening room on the third floor of Beijing Construction Engineering Contracting and Trading Center. The specific bid opening room is subject to that displayed on the display screen in the bid opening area (No. 32, Dongwangzhuang Community, Qinghua East Road, Haidian District, Beijing)(Submission method of bids: by hand or mailing; submission of bid by email is allowed and only for foreign bidder. If bid is submitted by mail, the bidder shall ensure that its bid is delivered to the address for opening of bids before the deadline for submission of bids, otherwise the Purchaser has the right to reject to the bid. If the bid is lost or damaged during mailing, the risk arising therefrom shall be borne by the bidder.
